3. Welcome

The Chair opened the meeting by wishing all members a very happy new year and thanked everyone for attending. The Chair also thanked members for what was a very healthy turn out at our Festive event held at the Howgate Centre in November (See item under Panel Initiatives). At this juncture, through the Chair, Robert Thomson, the Scottish Fire and Rescue Service Community Liaison Officer to Falkirk Council took the opportunity to thank members for donating the flame retardant clothing which will be used at some date in the future to protect people that are identified as being at possible risk to fire in their home.

4. Minutes of Previous Meeting

The minutes of the meeting of 28 November 2016 were approved by Madelene Hunt and were seconded by Chris McNaught.

5. Matters Arising

5.1 Bo'ness Community Safety Group (BCSG)

Madelene indicated that BCSG recently held a meeting at which the group's accounts had been approved and sent off to OSCR. Madelene also indicated that a valuable member of the group, Bill Kelly, had resigned. She also advised members that there had been an issue with the décor in the porta-cabin but this has been addressed and more local groups are beginning to use the facility.

5.2 Schools Quiz

Moira advised members that due to other pressures, she had nothing to report in regard to the schools quiz. A short discussion then ensued and Moira asked Drew if he had any ideas regarding the possible direction of this initiative and it was suggested that efforts should be made to hold the quiz in October/November. Moira agreed that she would endeavour to send emails out to the schools to this effect.

6.4 Panel Initiatives

Festive Initiative:

As previously reported in the minutes, the event held at the Howgate Centre had been well attended by members. It was generally agreed that although not as busy as previous years, a large number of crime prevention leaflets, including the identity theft sleeves had been handed out. It was also pointed out that the presence of a Community Fire Officer proved to be a welcome addition to the team on the day.

At this point it was suggested by Stuart Caplan that an approach should be made to The Falkirk Herald to ask if they would run an article on the workings of the Panel and thereby raise the profile of the group. Following a short discussion, it was agreed this should be done.

Action: Stuart to make contact with The Falkirk Herald and report back.

In regard to raising the profile of the Panel, the Chair advised members that the Dawson Bike Club would be attending the 'Wee Jaunt' cycle event that is due to be held in Falkirk in May and suggested that attendance at this event would also help to raise our profile, although the date and venue was still to be agreed.

With that in mind, a crime prevention leaflet on cycles was tabled and Dru was asked to take it to Police Scotland for comment with the possibility that it could be printed for this event. Stuart Caplan suggested that if this was to be done, it would be a good idea to link it into shed security and this was agreed. Stuart was then asked if he could revitalise this leaflet to include shed security and thereafter send it out for comment before bringing it to the next meeting for approval to print it.

Action: Stuart to revitalise the document to encompass cycle security and shed security and send it out for comment. Dru to report the thoughts of Police Scotland at next meeting.

Robert also suggested that the Panel should also consider attending the Emergency Services Day event that is organised by the Falkirk BID. This event is to be held in August.
