2. Apologies

3. Welcome:

All members agreed that Pat had been a positive influence in his support of the Panel and expressed their heartfelt sorry at his passing. After a minute of silence for reflection in memory of Pat, the Chair expressed her thanks to the management of Morrison's Supermarket for allowing members to meet in their community room on the premises.

5. Matters Arising:

5.1 Election of Office Bearers:

Scams Initiative:

The Chair advised that the scams event held at the Trinity Church Falkirk on 2 August was not very well attended despite being well advertised through a number of mediums with only one member of the public attending. That said, a number of excellent snippets of information were made known. The number 7726 is a good number to remember to dial in the event of suspected scams, and dialling 159 will provide a direct link to individual banks for scam support. Interestingly, it was noted that the TSB is the only bank that guarantees money obtained by fraud being returned to its customers although the other banks will do what they can to support their customers. The way forward was also discussed and it was agreed that an approach be made to Ian Livingston, Rector of the Braes High School to examine the possibility of holding a similar type event there.

The Chair and all those present thanked Mark Muirhead and Brian Mackie for their support and the valuable information they had provided.

Asda Grangemouth:

The Chair advised that Charlie, the community champion at Asda Grangemouth had been in touch to ask if the Panel would be interested in attending at the store again albeit this was tempered with a possible move she may make to the Falkirk store. After discussion, it was agreed in principle.
